Minutes of the AGM - DRAFT

The Chair, Jo Dytch(JD), welcomed everyone present on behalf of the board and staff of Mountaineering Scotland.

(a) Roll call and appointment of tellers.

CEO Stuart Younie (SY), reported that registration had been carried out in advance and a record of attendance had been taken and would be noted in the minutes. He also noted that Helen Gestwicki and Karen McVeigh were the appointed tellers.

(b) The approval of the minutes of the previous AGM and of any subsequent EGM

The Chair confirmed that the minutes from the 2023 AGM had been published on the website in advance of the meeting.

SY reported the results of the voting as follows: 3,196 in favour, 0 against, 428 abstentions.

No amendments or matters had arisen in respect to the minutes and therefore the 2023 AGM minutes were approved.





(c) The receipt of such reports as the Board may consider appropriate to bring before the AGM for approval or information

The Chair noted that the Annual Report had been made available online.

(d) The receipt of the Company's annual accounts and reports

Hazel Meehan (HM), Treasurer and Director of Finance, presented a pre-recorded summary of the financial report and began by confirming that the annual accounts for April 2022 to March 2023 had been prepared in accordance with financial standards and produced externally by accountants MMG.

HM reported that Mountaineering Scotland still faced very significant post-COVID inflationary pressures, and membership has been affected by the cost of living and general economic situation. The Financial Advisory Group and the Board have closely monitored the financial position and the landscape across our peers in the industry

It was noted that a surplus of £2,626 had been achieved against a budgeted deficit of £23,506 as a result of cost controls and a legacy donation of £19,600 which contributed significantly to this position.

Membership subscriptions remain the primary income source (57%) however these are starting to plateau, and growing membership is a focus for the team. sportscotland funding increased slightly to £252,050 down from 37% of total income to 35%.

Public liability insurance is a key part of our membership package and costs for this benefit have risen, from £44,000 back in 2021 to £116,648. The review of our insurance provision was an important exercise to undertake to position ourselves sustainably going forwards.

HM went on to provide an overview of how funding was allocated across the activities of the organisation and then reported projected deficits of £49k and £76k in next 2 financial years due to rising costs. To address this and ensure that current activities and services to members are maintained an increase of £6 to adult individual and £5 to adult club fees was proposed.

Questions:

- A question was received about the funding from Braemar MRT and SY confirmed that MScot had a long-standing relationship with the team who had generously funded our student activities over the last few years. A letter of thanks had recently been sent by the President.
- A comment on the impact of the proposed increase in fees on older club members who were not active members was noted.
- A question was raised about the likelihood of a reduction in funding from sportscotland
 given the pressure on public sector finances. JD and SY had both attended the investment
 review meeting in Oct and had been encouraged to ask for an uplift in funding and received
 very positive feedback on the submission. Although the exact figures would not be
 confirmed until the new year there was confidence that a robust proposal had been made
 but as a contingency a hold had been put on replacing a vacancy within the ClimbScotlsand
 team until the investment figure was confirmed.
- A question was asked about whether any assessment was done in relation to members leaving because of cost-of-living pressures. It was confirmed that an exit survey was caried out with all leaving members to identify the reason for not renewing their membership. Cost

pressures had been a factor over the last couple of years however other reasons such as moving away and no longer being active in the hills had also been identified. Looking at previous data, a conservative estimate had been put on membership increases in the budget forecasts to mitigate against this risk.

- A question was raised about applications for trust and grant funding, and it was noted that
 options were being explored but were limited due to MScots legal status as a not-for-profit
 company rather than being a charity.
- A question was received about the potential to share financial updates with members on a quarterly basis. It was confirmed that this was the role of the Finance Advisory Group and they would consider the request.

(e) The fixing of members' annual subscriptions

The chair confirmed that this item had been widely discussed over previous weeks and proposed to move straight to the vote.

SY reported the results of the vote which were 3,319 in favour, 240 against, 65 abstentions.

The increase in membership fees was approved.

(f) The election of the Board members

The President Anne Butler stepped in to chair this Item and reported that 3 directors were standing down at this AGM:

- Jo Dytch, standing down as Director for Clubs with Stephen Johnson proposed to take over
- Dominic Hall, standing down as Director for Landscape and Planning with Andrew Tait proposed to take over
- Hazel Meehan, standing down as Treasurer and Director of Finance with Fiona Bennett proposed to take over

Thanks were noted to JD for 6 years' service in the role of Director for clubs and thanks were also noted to HM and DH for the contribution they had made to the Board during their terms of office.

Two Directors were seeking approval to extend their term of office by a further two years:

- Ilona Turnbull, Director for Governance, HR and Equalities
- Alistair Todd, Director for snowsports touring

All other directors are eligible to remain in office and are prepared to do so.

Votes regarding the three vacant positions and the two extensions to existing terms of office were shared by SY:
