Proposals on updating target ambition

One might have this as an aspiration but it is impossible to know when it might become even theoretically possible. Rather than give power to Ministers to act possibly decades hence, it would be more appropriate for the issue to return to the Scottish Parliament as a formal amendment to, or full refresh of, the (by then) Climate Change Act.

3a Do you agree that the 2020 target should be for greenhouse gas emissions to be at least 56% lower than baseline levels?

Please explain your answer:

The target apparently assumes a continuation in each year to 2020 of the 3 percentage points reduction achieved in 2014-2015. Over the past decade the annual reduction has been nearer to 2% than 3%. A target more modestly above 50% would be more consistent with the trend, though the replacement of Longannet's territorial emissions with imported (and thus uncounted) emissions from gas-fired generation in England to compensate for the intermittency of Scotland's unbalanced wind-dominated renewables generation portfolio might enable the 56% to be met (or might be lost in the emissions-trading fudge).

This is a desirable simplification. Emissions targets have taken a fairly simply proposition (the need to reduce emissions very substantially), albeit with genuine challenges of measurement, and made it unnecessarily and unhelpfully complicated in its presentation.

No objection in principle to varying interim targets, though scope for manoeuvre appears limited unless there is a rapid disruptive worldwide change in energy technology (e.g. development and massive adoption of thorium reactors) or the level of ambition is to be diminished. Changing 2050 targets should only be through a full parliamentary process (cf question 2).

What do you think are the most important criteria to be considered when setting or updating emission reduction targets?:

It has to be driven by scientific knowledge and technological capability. The other considerations are appropriate 'to have regard to' but reference to the 'renewable energy sector' should be removed: the issue is low-carbon, not particular technologies.

What are your views on these initial considerations of the impact of the Bill proposals on Scotland's people, both now and in future generations?: The stark challenge any small polity faces in an increasingly turbulent global environment – unstable ecologically, economically and politically – is simply surviving and maintaining and making more equitable the standard of living of its people. It is inconceivable that this involves a larger population consuming more, either at a local or a planetary scale. So the government's climate change ambitions sit in direct contradiction to much other government policy. Progress will stall if the government continues to believe/pretend that we can adapt simply with a green-tweaked version of 'business as usual'.

Please use this space to tell us any other thoughts you have about the proposed Climate Change Bill not covered in your earlier answers.: More humility would be appropriate rather than boasting about Scotland's international leadership role – a role largely invisible from outside Scotland. Progress against targets may look good in terms of percentage reductions, but Scotland started from a high base. Scotland's per capita territorial emissions are still significantly higher than the EU average – of the order of 20% higher – and exceed those of most individual EU countries. This is catch-up, not leadership.

A target based on territorial emissions is not good enough. The true impact of Scotland's population upon climate change is its carbon footprint (i.e. the totality of emissions attributable to the Scotlish population and its consumption). There is an increasing divergence between Scotland's territorial emissions and its carbon footprint, as shown in Chart 9 of Scotland's Carbon Footprint 1998-2013 (Scotlish Government, April 2017). In terms of carbon footprint, we have started to go backwards. Ambition on territorial emissions is meaningless without the same ambition for Scotland's carbon footprint.
