Do you deserve our vote? Political parties urged to protect to Scotland's mountains

Political parties are asked to state their views on six priorities for Scotland's mountains to help hill walkers, climbers and mountaineers decide where to place their vote on 5 May

With one month until the Scottish Parliamentary Elections, the Mountaineering Council of Scotland (MCofS) has written to the chairs of Scotland's main political parties urging they state their party's views and commitment to six priority areas for protecting Scottish mountains.

The organisation plans to share these responses with its 13,000 members and many more supporters from Scotland's hillwalking, climbing and mountaineering community to help inform individuals' voting decisions.

Mike Watson, President of the MCofS, explained: "We sent our election briefing, <u>A Sustainable Future for Scotland's Mountains</u> to over 250 parliamentary candidates and sitting MSPs earlier this year, and our members are now keen to hear parties' responses to our six priorities for political focus."

The MCofS has highlighted six key priorities:

- To develop a shared vision for Scotland's uplands, which should be treated as an irreplaceable natural, cultural and economic asset, respected and safeguarded for the benefit of all.
- To support sustainable economic development for mountain communities, which need support and investment to diversify and develop.
- To enforce existing legal powers and safeguard Scotland's access rights, which are so essential for the nation's health and wellbeing, but which are under threat of erosion.
- Guaranteed planning protection for mountain landscapes, so that development is planned and regulated to enhance rather than diminish our mountain landscapes and wild land.
- To capitalise on the health and wellbeing benefits of outdoor recreation, with these being promoted in both education and health services.

A commitment to improving safety in the mountains. A sector-wide Mountain Safety
Group, led by the MCofS, is developing a strategy for improving safety in Scotland's
mountains, and Government investment in safety services such as mountain weather
and avalanche forecasts, training and mountain rescue plays a vital part in this and must
continue.

The MCofS, which is encouraging its members and supporters to hold their parliamentary candidates and canvassers to account on these six matters, will publish all the responses it receives from Scotland's political parties on its website and in a pre-election communication to its nearly 13,000 members in the run up to polling day.
